

ADDENDUM TO THE
December 11, 2008
Memorandum of Understanding on
Pacific North Coast Integrated Management Area
Collaborative Oceans Governance

between

The Department of Fisheries and Oceans
(a Department of the Government of Canada)

and

First Nations of the Pacific North Coast
(as represented by Coastal First Nations (CFN) and the
North Coast – Skeena First Nations Stewardship Society (NCSFNSS)¹)

(Collectively the "Parties")

WHEREAS

- A. The Parties entered into the December 11, 2008 Memorandum of Understanding on Pacific North Coast Integrated Management Area; Collaborative Oceans Governance (the "2008 MOU")
- B. The 2008 MOU contemplates the Province of British Columbia becoming a party to the 2008 MOU.
- C. The Province of British Columbia had advised the Parties that it wishes to become a party to the 2008 MOU.
- D.

THEREFORE, the Parties agree to amend the 2008 MOU as follows:

- 1. In the title, by adding 'The Province of British Columbia (as represented by the Integrated Land Management Bureau) ("ILMB")' as a Party.
- 2. In the recitals, by adding a new Article D:

'D. The British Columbia Ministry of Environment ("MOE") has a mandate for advancing the Province of British Columbia's interests in oceans management and marine fisheries, and ILMB has a mandate to address the interests of the province by developing agreements and plans for the use and management of marine and foreshore areas.'


¹ Assumed for this draft that the Nanwakolas addendum/amendment is likely to come after the BC addendum/amendment, so Nanwakolas is not referenced here as a party.

3. Any references to the PNCIMA Collaborative Governance Model in the 2008 MOU and PNCIMA bilateral coordination, including but not limited to the Bilateral Coordination Steering Committee and the Secretariat, should all be considered to be references to trilateral coordination that includes the Province as well as the other Parties, and the 2008 MOU is amended accordingly.
4. This addendum is signed by the Parties, and the Province of British Columbia, on the 16th day of September, 2010.




